Hints from the Fog by Mike Ball, President



"When in Trouble, Do Tasks"

A great many companies, departments, groups, and clubs often have setbacks or roadblocks from time to time. Some grind to halt and wait for directions or something to change. This is easy to do but not very productive. Some people say to not do anything if you or your company run into problems. They claim they are waiting for direction or answers before they continue on the project. Those people subscribe to the old excuse "I am waiting for directions". Well perhaps they have a point, and I do believe "if you find yourself in a deep hole, then quit digging."

Sounds funny but stop digging does not mean stop working. As an inventor I have often run into roadblocks or timing issues that may hold up my invention process for a while. That does not mean I should sit down and wait for the roadblock to be removed. As an inventor, you are the only person who has to get it done.

I always create a matrix of what I need to accomplish to take my inventions to the market. It contains the task, who it is assigned to, estimated date it needs to be completed, and actual date it is completed. This document is the road map of your invention plan. One road can be closed if a bridge goes out but you have to continue the trip by a modified course.

An invention requires many type of items to accomplish to be successful and many are not dependent on any other task.

Take the design of a part that needs a CAD designer and yours is busy and can't work on it right now. This is a problem, but not a "dead in the water" issue because you still have many other tasks that need to be done. If you are using the "Invention Matrix" which all our new members receive, just go to your matrix and work on some task you need to do anyway. This makes your time productive and many times when you are doing tasks you must do anyway, you are working on you invention successfully.

So many inventors get set on working on one item that they think must be completed before they can do anything else. What does setting up an office system have to do with a design? Nothing. What about doing market research about your competition, or taking out a DBA, or setting up a work area, or obtaining a bar code? Nothing, but all these tasks must be done if you want to sell or market your invention. So when you are in trouble, do tasks that will be required anyway. "If it's going to be, it's up to me." Keep working and you will eventually complete them all. Happy Inventing.
