Want to be a Successful Inventor ???

Being a member of the Inventors Council of Mid-Michigan (ICMM) since 2004 and President for the last seven years, I have seen many people with good and bad ideas. First of all, we are all volunteers trying to help other inventors be successful with their invention ideas. We are experienced in engineering, design, manufacturing, packaging, marketing, distribution, and many other skills. We are helpers, not employees, workers, finance source, designers, business plan writers, and many other things people want us to do for free.

We have written guides and step by step reviews for people to follow. Some people think we will do all the work for them. No we don't. We advise and share our experience, not become a would be inventor's workers.

We provide a step by step matrix and list of what an inventor needs to do to be successful. When I worked for a large automotive company we tried to copy a Japanese company procedure. They had a 12 step process that they used to be successful. We send hundreds of people to their plant (we owned half of it) And came back with an "identical process". Except ours was a 10 step process and we changed the order of some of the steps. It was not the same process at all when we finished and we failed. We later went bankrupt with that method.

I watch many inventors do the same thing. They tell us that they have the greatest idea in the world and they just need help in marketing it. When I ask to see the product, they either say it's a secret or they show us a sketch or drawing. Now they want to skip all the steps that make you prove the idea can be turned into a product and then into a business.

We don't tell inventors what they want to hear. We tell them what they need to hear and it is up to them whether they want to listen.

Invention Companies operate on the "what you want to hear" philosophy. They are full of promises as long as you are paying them. They tell you they have all the industry contacts and then give you public information from the company directory. An inventor needs to lose money because they refuse to follow the invention process with all its safeguards listed to protect them. This is one reason ICMM was created.
